#2. No Hands On (Business)\$2,000.00: Includes all of #1 plus a custom web page designed to fit the needs of the company and it's products being sold on-line.

#3. No Hands On (Entrepreneur) \$5,000.00: Includes all of #1&2 plus your own social network to fill-in from scratch, a great way to manage employees within your company. Keeping company networking private and global. Also a great way to organize your next big movement / big project. This is the only option for Motion Picture Production.
